### Neutral DBE Participation Collection/Credit Additional Attachment A Process

**We need your help! We need accurate reporting of DBE engagement on WisDOT projects—not only to help determine whether DBE goals are met but also for setting future goals.**

**Adding a DBE contractor to a project after the original DBE commitment is approved, submit Attachment A from the DT1506. It must be:**

- Signed by the prime contractor and the DBE
- Submitted after first payment to record accurate participation

**Additional Attachment A?** They can be submitted throughout the project.

**Trucking after award/execution:**

- Only submit Attachment A for DBE trucks that were not on the DT1506
- Do not submit attachment A for additional amounts for DBE firms included with the bid
- OBOEC will confirm trucking commitment and utilization using CRCS, payment reporting, the Trucking Schedule and hiring agreement. All payments to any DBE at any tier must be reported in CRCS.
- Final Attachment A is not required for trucking but must be submitted if requested for CUF monitoring.
