#### Purpose of the handout


The Wisconsin Department of Transportation (WisDOT) is proposing improvements on WIS 23 from County P to Taylor Drive in the towns of Plymouth and Sheboygan Falls, the village of Kohler, and the cities of Sheboygan Falls, Plymouth, and Sheboygan in Sheboygan County. The purpose of the handout is to provide information regarding the proposed projects and to describe the potential impacts they will have on the community.

#### **Public input/comments**



#### **Project location and limits**

Project 1440-41-71 runs for approximately 10.5 miles from County P to WIS 32 in the towns of Plymouth and Sheboygan Falls, and in the city of Plymouth.



Project 1440-42-71 runs for approximately 3.9 miles from WIS 32 to Taylor Drive in the towns of Sheboygan Falls and Sheboygan, in the city of Sheboygan, and the village of Kohler.



## **Proposed Improvements**

The proposed improvements for Project 1440-41-71 and Project 1440-42-71 include the following:

- Repair concrete and overlay the existing concrete pavement from County P to WIS 32, about 10.5 miles long
- Repair concrete, mill and overlay the existing pavement from WIS 32 to Taylor Drive, about 3.9 miles long
- Reconstruct the intersection at WIS 23 and Sunset Road
- Reconstruct the intersection at WIS 23 and County TT
- Replace beam guard
- Replace culvert end-walls

#### **Right of Way Needs**

A minor amount of real estate is needed (approximately 0.249 acres) for the reconstruction of Sunset Road and WIS 23 and for County TT and WIS 23.

#### **Traffic Impacts**

WIS 23 will be open to traffic throughout the majority of construction. Traffic control in the form of single-lane closures on WIS 23 Eastbound and Westbound will be used during construction activities. Also, temporary lane closures and access restrictions will occur on Sunset Road and County TT during construction. Access will be maintained for all residents and businesses.

### **Project Schedule**

Preliminary design: Fall 2022

Right of way acquisition: Spring 2023 through Spring 2025

• Final plans: Spring 2025

Construction is tentatively scheduled for 2028 but may be moved up to 2026
