#### Purpose of this handout

The Wisconsin Department of Transportation (WisDOT) is seeking public feedback for proposed improvements on I-41 in Fond du Lac County. The purpose of this outreach is to obtain your input on the identified needs and proposed improvements within the project limits. There will be no in-person public meeting due to the current health emergency. We appreciate your input and encourage you take a moment to review the project information and provide comment.

#### **Project location and limits**

This project is located on I-41 in Fond du Lac County at the Town Line Road overpass.



#### **Project need**

WisDOT is proposing to rehabilitate the overpass carrying Town Line Road traffic over I-41. The existing bridge structure is deteriorating, and the deck is in need of replacement.

#### **Proposed improvements**

- Replace bridge deck
- Abutment spot repair

#### Anticipated traffic impacts

Construction is currently scheduled for 2023.

During construction, there will not be a signed detour route. Town Line Road access for residents and emergency services will remain open for the duration of the project. I-41 may be reduced to one lane in either direction at the overpass location.

#### Real estate

There is no right of way acquisition anticipated for this project.

#### Project update/next steps

The design process for this project is expected to conclude in 2022, with construction tentatively scheduled for 2023. The environmental review is scheduled to be completed in winter 2021.


