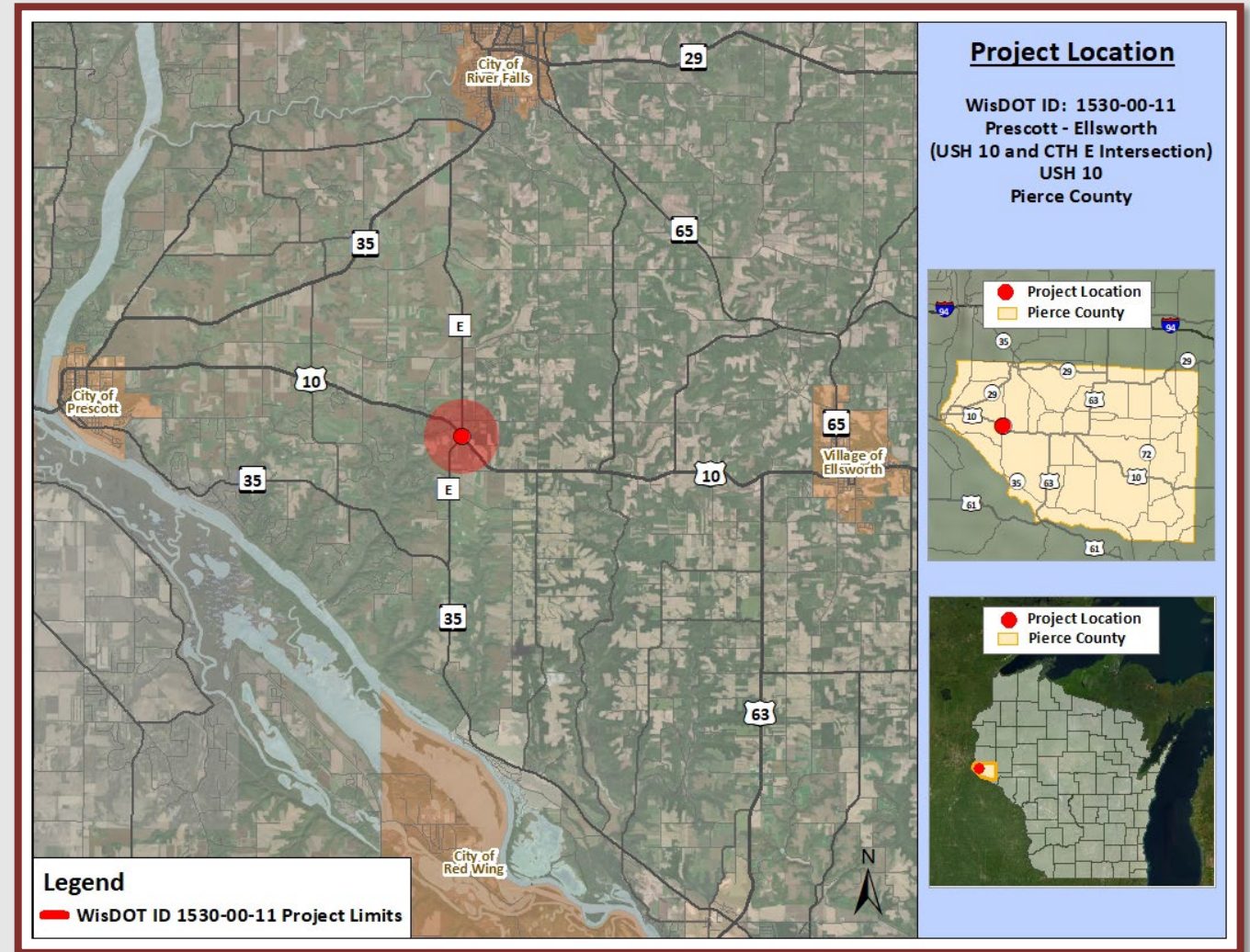

Project Location

- Limits:
 - US 10 and County E Intersection





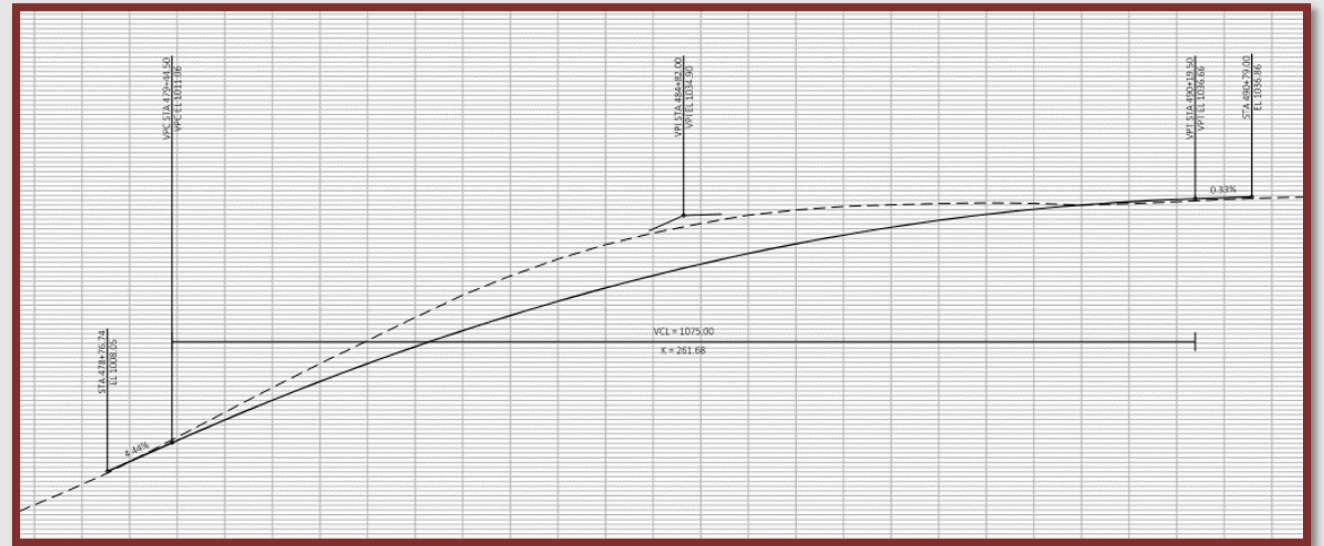
Purpose and Need

- Purpose
 - Address the safety and operations of the intersection
- Need
 - Documented crash history
 - Issues with sight distance along US 10 approaching the intersection



Proposed Improvements

- Lower the vertical curve on US 10 east of the intersection by approximately four feet
 - Improve sight distance
 - Reduce the chance of crashes at the intersection



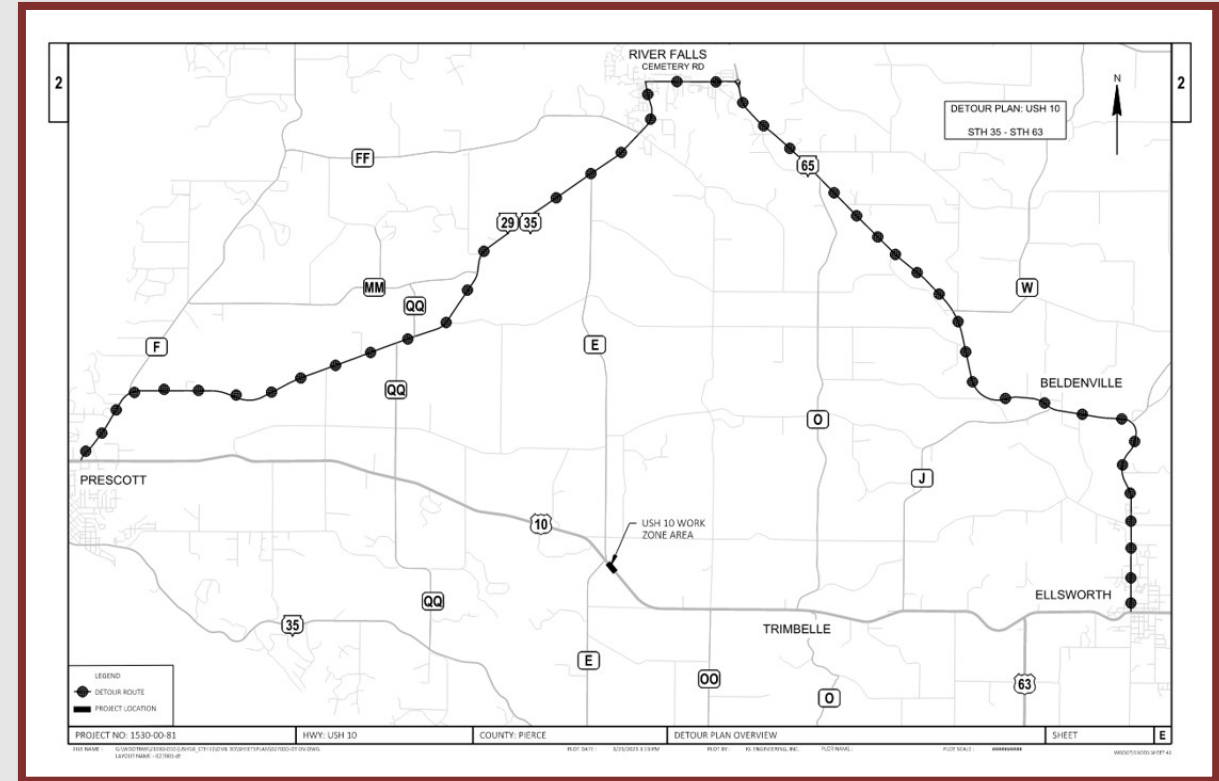
Construction Staging

- 2025 construction season
 - US 10 and County E intersection to be closed during construction
 - US 10 traffic to be detoured



Detour Route

- Proposed detour routes:
 - Westbound US 10 traffic: WIS 65 to WIS 29/35 to US 10
 - Eastbound US 10 traffic: WIS 29/35 to WIS 65 to US 10





Real Estate

- Permanent right of way and temporary limited easements are needed for earthwork grading operations.
- The real estate acquisition process is expected to begin in fall 2023.





Schedule

- Virtual Public Involvement Meeting August 2023
- Real Estate Acquisition August 2023 to August 2024
- Final Plan Submittal August 2024
- Construction 2025
