The Wisconsin Department of Transportation (WisDOT) is developing plans to make improvements to approximately three miles of WIS 32 (Douglas Ave.) from 1400' north of 4 Mile Road to 800' south of E. County Line Road in the Village of Caledonia and Racine County.

Proposed Improvements

- Mill 4-inches of existing pavement – repave with 4-inches of asphaltic pavement
- Pave five-foot shoulders
- Re-dress gravel shoulder areas
- Update curb ramps at MRK Trail (near Middle Road & WIS 32 intersection)
- Install monotube signals at Middle Road and WIS 32
- Replacement of culvert pipes and inlets on the south end of the project

Real Estate

Potential Temporary Limited Easements (TLE) may be required for culvert repairs

Traffic Impacts During Construction

Construction is currently scheduled for 2026. Traffic control in the 4-lane area (2-lanes in each direction) will be through the use of single lane closures. In the 2-lane area, traffic control will be through the use of a flagging operation.

- Temporary driveway closures will be needed during milling and paving operations
- The contractor will be required to give advance notice
- Most closures will be short term (meaning a few hours)
- Business access will be done in halves, if there is only one access point
- Side streets will remain open to local traffic only
- 7 Mile Road intersection will be staged
