The Wisconsin Department of
Transportation (WisDOT) is pleased to
present the preferred roadway rebuilding
improvement plan for Lake Drive
(WIS 32) located in Shorewood. The
proposed preferred improvement plan is
based on a comprehensive evaluation of
options. The proposed final plan preserves
treasured trees, on-street parking,
pedestrian crossing safety improvements,
and on-street buffered bicycle lanes.

PROJECT PURPOSE AND NEED




The purpose of the project is to address deteriorating pavement conditions, improve bicycle and pedestrian accommodations, and replace aging municipal underground facilities in the Village of Shorewood. The estimated construction cost estimate ranges from \$8M to \$9M. WisDOT funds vehicular and bicycle lanes; the Village funds parking land, municipal street lighting, sewer, and water main.

PREFERRED ALTERNATIVES

Buffered 5-Foot Bike Lane (Parking at Curb):


The preferred road rebuilding plan includes:


- One vehicular travel lane in each direction
- Buffered on-street bicycle lane in each direction; providing separation between traffic and bike lane
- On-street parking lane along the east side of the roadway
- Two new on-street ADA parking stalls at Atwater Park
- New roadway width matches current roadway width



Capitol Drive Intersection:

The roadway between Shorewood Boulevard to Capitol Drive will match the current configuration. Changes are proposed for about 500 feet north of Capitol Drive with a wider northbound lane to provide additional room for on-street biking. At the request of input received throughout the evaluation process, the new roadway is limited to the space within the current roadway width. Roadway widening restriction prohibits the ability to provide buffered bike lanes matching the rest of the roadway.





PROJECT COMPONENTS

The project will rebuild the roadway from curb to curb and improve pedestrian and bicyclists safety by including the following components:

- · ADA curb ramps at all intersections
- Curb extensions ("bump-outs") at five intersections
- On-street ADA parking at Atwater Park

The curb extensions will be located at:

- Edgewood Avenue
- Menlo Boulevard
- Jarvis Street

- High-visible painted crosswalks at six intersections
- Flashing pedestrian crossing beacons at Menlo Boulevard and Jarvis Street
- Olive Street
- Kensington Boulevard

Most existing sidewalks will remain. The project will include new sidewalks at curb ramps, sewer and lateral crossings, driveway aprons, and a sidewalk near Atwater Park. The project will also replace storm sewer inlets and laterals, install new street lighting with LED luminaries, and new green-painted monotube traffic signal equipment at the Capitol Drive intersection to locate sign heads over each lane.

February 28, 2023: Thirty day comment period ends

April 1, 2023: Environmental document **June 25, 2023:** Final right-of-way plat

July 1, 2023: Begin real estate acquisition

May 1, 2024: Complete real estate acquisition

June/July 2024: PIM #4 (to review construction staging/access)

August 1, 2024: Final plans

2025: Construction
