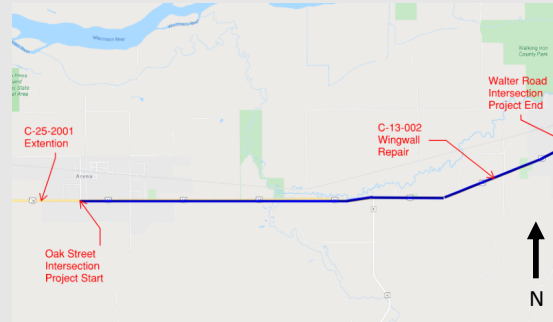

Project location

- 5.8 Miles of US 14
- Oak Street – Walter Road
- Village of Arena, Village of Mazomanie, Town of Arena, Town of Black Earth, and Town of Mazomanie.
- Iowa and Dane Counties



This project will take place on nearly six miles of US 14 within the village of Arena, the village of Mazomanie, Town of Arena, Town of Black Earth, and the Town of Mazomanie. The project limits will be between the intersections of Oak Street in Arena and Walter Road in Mazomanie.

Why do we need this project?

Pavement deterioration and roadway safety

- Rutting, longitudinal cracking, and transverse cracking.



The project will improve the safety, comfort, and longevity of the highway. This section of US 14 is exhibiting pavement cracking and wheel path rutting. These pavement deficiencies are increasing both safety concerns and maintenance costs. If no action is taken, this roadway will continue to deteriorate, and maintenance costs will continue to increase.

Why do we need this project?

Deterioration of culvert structures

- Spalling concrete and exposed rebar requires repair.



Within the project area, there is also a culvert and a cattle pass that are showing spalled concrete and exposed rebar which require repair to extend the life of the structures.

Proposed improvements

Design overview

- Pavement
 - Mill off 2.5-inches asphalt
 - Replace with 3.5-inches asphalt
 - New rumble strips, pavement markings
- Culvert extension
- Cattle pass repair
- Upgrade guardrail within project limits



The proposed improvements include resurfacing of US 14, installation of centerline and shoulder rumble strips, upgrading the guardrail, and updating the pavement markings. Structure repairs will occur to the cattle pass west of the Mazomanie village limits along with repairs and culvert extensions to the box culvert just west of Arena village limits.

Real estate and traffic impacts

Real estate

- Permanent right of way needs
 - C-25-2001 Culvert Extension
- Temporary easement
 - C-25-2001 Culvert Extension

Traffic impacts

- Flagging will be used through out project
- Business and residential access will be maintained during construction



The project will require minor right of way acquisition and temporary easements at the culvert extension west of Arena.

The project will be constructed under flagging operations, allowing traffic to continue along the highway. All residential and commercial access will be maintained during construction.

Project schedule

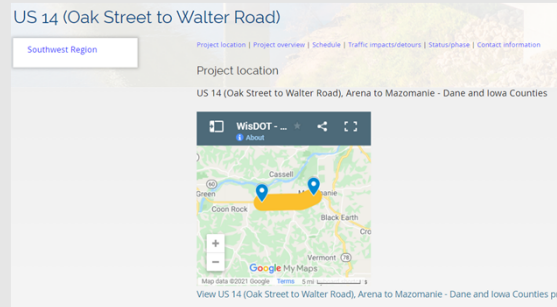
We encourage public feedback on the proposed improvements and you can submit input via the comment form on the website or contacting project staff listed on the last slide.
