(Sheridan Street to East County Line)

Overview

The project is designed to improve safety, operations and pavement conditions on WIS 21 in Juneau County, including improvements at the WIS 21/WIS 80 intersection and the WIS 21/County G intersection.

Project Location

The project limits are WIS 21 between Sheridan Street, Necedah, and the east Juneau County Line/Wisconsin River.

Recommended Improvements

- Replace the concrete pavement at the WIS 21 and WIS 80 intersection
- Resurface WIS 21 and WIS 80
- Replace traffic signals at the WIS 21 and WIS 80 intersection
- Construct a roundabout at the WIS 21 and County G intersection
- Upgrade all non-compliant curb ramps along WIS 21
- Replacing safety beam guard along the entire length of the project
- Install rumble strips along the entire length of the project
- Replace pavement marking

Real estate

Real estate strip acquisition will be needed at the WIS 21 and WIS 80 intersection for curb ramp improvements and at the WIS 21 and County G intersection for the roundabout. Temporary easements will be required for other improvements along the project.

Proposed traffic impacts

During construction of the WIS 21 and WIS 80 intersection, WIS 21 will have short term closures to through traffic. The proposed detours will use WIS 173 and WIS 80 for one stage and WIS 80, WIS 58, WIS 82 and WIS 13 for the other stage. During the completion of the resurfacing operations, WIS 21 will remain open to traffic and constructed with single-lane closures through flagging operations.
