**PROJECT INFORMATION**

WisDOT is proposing to improve approximately 8.11 miles of WIS 23 from Elder Ridge Road to County K, which was last reconstructed/resurfaced in 2005. The existing pavement is aged and exhibits signs of fatigue including alligator, longitudinal, and transverse cracking.

**The proposed improvements include the following:**

- Remove existing 4"-5.5" of asphaltic surface and pave new 5.5" HMA pavement
- Guardrail replacement
- Curb ramp replacement to ADA standards
- Culvert replacement (5)
- Water/Sanitary Sewer replacement including subgrade improvements (Village of Loganville)
- Inclusion of left turn lanes at Southridge Blvd (City of Reedsburg)
- Add new pavement markings/centerline/shoulder rumble strips

**PROPOSED TRAFFIC IMPACTS**

Construction is currently scheduled to begin in Spring 2025 and is expected to be completed in Fall 2025.

WIS 23 will be detoured during construction. Two routes are planned WIS 23 to WIS 130 to WIS 154 to WIS 23 and WIS 23 to WIS 60 to US 12 to WIS 33 to WIS 23. Temporary driveway closures may be necessary during parts of the construction process. Construction staff will contact homeowners and businesses in advance before closing a driveway. If you have special access needs during construction please let us know so these can be considered as much as possible, and if needed, included in the bidding documents.

**REAL ESTATE**

A minor amount of real estate will be acquired for curb ramp, culvert pipe and guardrail replacement.
