

WIS 23
County GG to Elder Ridge Road
Sauk County

PROJECT INFORMATION

WisDOT is proposing to improve approximately 5.24 miles of WIS 23 from the intersection of County GG to the intersection of Elder Ridge Road, which was last reconstructed/resurfaced in 1998 with only routine maintenance work being performed since. See the attached project location map. The existing pavement exhibits signs of deterioration in the form of rutting, raveling, fatigue cracking, longitudinal cracking, and transverse cracking.

Proposed improvements include:

- 1) Extending the service life of the asphaltic pavement
 - a) Mill approximately 2" of the existing asphaltic surface
 - b) Overlay with 4" of HMA pavement
- 2) Replace curb & gutter
- 3) Lining culvert pipes
- 4) Replace guardrail and end terminals throughout the project
- 5) New pavement markings and add centerline and shoulder rumble strips

PROPOSED TRAFFIC IMPACTS

Construction is currently scheduled to begin in the summer of 2027 but could begin as early as 2026 and is expected to be completed within 12-14 weeks.

WIS 23 will remain open to through traffic during construction through the use of flagging operations. Temporary sideroad intersection and driveway closures may be necessary during parts of the construction process. Construction staff will contact homeowners and businesses in advance before closing a driveway. If you have special access needs during construction, please let us know so these can be considered as much as possible, and if needed, included in the bidding documents.

REAL ESTATE

A minor amount of real estate will be acquired for guardrail replacement areas and drainage improvements.
