SUBJECT: **WIS 23 Resurfacing Project Notification and Virtual Public Involvement**

Mineral Point – Spring Green  
Wisconsin River Bridge to US 14  
WIS 23, Sauk County

Dear property owner or resident:

The Wisconsin Department of Transportation is developing plans for a proposed resurfacing of WIS 23 between the Wisconsin River Bridge south of Spring Green and US 14 north of Spring Green. The initial design includes resurfacing the roadway (between Pecks Landing's driveway and US 14), curb ramp updates to meet Americans with Disabilities Act standards, a 300-foot section of subgrade improvement (between Madison Street and the railroad), and one culvert pipe improvement. The pavement markings will be updated throughout the project. Centerline and shoulder rumble strips are proposed south of Spring Green where the roadway is 55-mph. This improvement project is currently scheduled for construction in 2024.

During the subgrade improvement, approximately 2 weeks, the roadway will be closed to through traffic with a posted detour route on State owned roadways. Access will remain open to local property and businesses. For the remainder of the project the road will be open to traffic under flagging operations.
