Purpose

The purpose of this meeting is to inform the public and gather input about the proposed roadway work on WIS 89 between Clarkson Road and Avalon Road.

Department officials will notify the public with letters to nearby residents, business, and stakeholders. The letter will include the website location URL along with a handout and comment form.

The Department will also be available via phone and email to address specific concerns.

Project Information

WisDOT is proposing to improve 9.77 miles of WIS 89. Proposed improvements include: reconstructing the intersection at WIS 89 and County TV, structure replacement over Mud Creek, roadway resurfacing, culvert cleaning and repair, and pavement marking. The reconstruction typical section will consist of 4-inches of HMA pavement over 10-inches of base aggregate dense 1 ½-inch material. Subgrade improvements will consist of 16-inches of select crushed material.

The existing horizontal curve at the County TV intersection has a radius of 109-feet which is well below what is required. There have been seven (7) crashes between 2013-2017 directly related to the substandard geometric features of this intersection. After analyzing several alternatives, the project team is proposing to flatten the horizontal curve radius from 109-feet to approximately 430-feet and lower the vertical curve located north of the intersection.

The project also proposes to replace the structure along WIS 89 over Mud Creek. The current structure has significant scour at the south abutment in addition to slab delamination and cracking on the surface. The structure replacement and associated beam guard will include minor temporary and permanent grading into existing wetlands.

Proposed Traffic Impacts

Construction is scheduled to begin in summer of 2024.

During construction, WIS 89 – between Clarkson Road and Avalon Road – will be temporarily closed utilizing WIS 73 as the detour route. Access will be maintained for residents and businesses to the greatest extent possible.

Construction is currently scheduled for completion in fall 2024.

Real estate

Additional right of way and temporary limited easements will be required for this project. Acquisitions will be near the intersection reconstruction area and at the structure replacement area. Preliminary right of way impacts are shown on the exhibits. The Department expects to begin real estate acquisition in Fall 2021.
