**ADDENDUM NO. 1**

**Special Provisions**

**5. Traffic.**

Replace the section Central Segment with the following:

**CENTRAL SEGMENT**

**PreStage 1 – Stage 2**

No lane closures are allowed within the Central Segment during Pre-Stage 1 through Stage 2.

**Pre-Stage 3**

During Pre-Stage 3, single-lane closures on USH 41 are only permitted during the following times (center lane cannot be closed):

**Single-Lane Closures Permitted**

**Southbound**

- 6:00 PM Sunday, Monday, Tuesday, Wednesday, Thursday to 6:00 AM the following day
- 6:00 PM Friday to 12:00 PM Sunday

All USH 41 northbound lanes must remain fully open to traffic within the Central Segment.

**Stage 3 – Stage 4**

During Stage 3 and Stage 4, USH 41 southbound is reduced full time from three lanes to two lanes within the Central Segment.

Multi-lane closures where USH 41 southbound can be further reduced from two lanes to a single lane shall only be allowed for the following construction operations:

- Installation, removal and repositioning of temporary concrete barrier between construction stages
- Removal of existing concrete approach slabs
- Construction of asphalt bridge approaches

Multi-lane closures are only permitted during the following times (center lane cannot be left open as a single lane):

**Multi-Lane Closures Permitted**

**Southbound**

- 9:00 PM Sunday, Monday, Tuesday, Wednesday, Thursday to 5:00 AM the following day
- 10:00 PM Friday to 8:00 AM Saturday
- 7:00 PM Saturday to 10:00 AM Sunday

All USH 41 northbound lanes must remain fully open to traffic within the Central Segment.
