**ELECTRONIC BIDDING**

**PROPOSAL GUARANTY**

Certified checks shall be drawn on the account of the bidder submitting the proposal. The bidder may also satisfy the proposal guaranty requirements by having a properly executed annual bid bond on file with the Department.
